

17th Annual Adoption Conference to Focus on Our Changing Lives

"This year's Barker conference—more than any other conference I've been involved with, and I've been involved with a lot of them—is about all of our lives."

This assessment comes from Chris Intagliata, 2011 conference coordinator. "It's about the normal changes in our lives, but we're looking at the ways in which those normal changes are affected by the simple fact that adoption is a part of our stories."

Turning Points: Transitions Throughout the Lifetime of Adoption, Barker's 17th annual conference, will be held April 2, from 9 am to 4:30 pm at the Universities of Maryland Conference Center at Shady Grove. The Robin B. Allen Memorial Keynote Address will be delivered by Joyce Maguire Pavao, the well-known adoption clinician and founder of Center for Family Connections in Cambridge, Massachusetts and New York City.

"All of us who belong to what some are now calling the 'adoption constellation' understand that we're just like everyone else—but we know we're different, too," explains Marilyn Regier, Barker Foundation Executive Director. "This conference is going to explore the ways in which adoption shapes our life passages—all the way through grandparenthood! Participants will come away with useful information about managing those transitions, and they will also hear some wonderfully moving stories."

Life after placement for birth parents, the early school years for children who were adopted, the change from foster care to permanency for older children, how

adoption affects the launch into adulthood, impacts of search and reunion, and many more discussions will fill breakout sessions geared toward adoptive parents and prospective adoptive parents, birth parents and adopted persons, foster parents and adoption professionals. A plenary panel at the end of the day—at once both thoughtful and provocative—will feature Barker's young adult adoptees talking about the role of the internet and social networking in adoption.

This will be Dr. Pavao's third appearance at a Barker conference. Other prominent guest speakers include Judy Stigger, an adoption therapist at The Cradle in Chicago, Illinois and pioneer in online adoption education; Aaron Stigger, Judy's son, who will present with

his mother on the lifetime effects of transracial and transcultural adoption; Cynthia Mabry, an adoption law expert from Howard University School of Law; and Trish Maskew, the author of *Our Own: Adopting and Parenting the Older Child*.

"This conference is going to go to the heart of it, for all of us," Chris predicts. Marilyn agrees, "It will be

a substantive, compelling day. And what could be more appropriate than a keynote in Robin Allen's memory? Barker's conferences are truly one of Robin's legacies. She was passionate about lifelong adoption education." Robin Allen, who died in July 2010, was Barker's Executive Director from 1986 to 2000. The conferences began during her tenure.

FROM THE *Executive Director*

After a banner year such as Barker experienced in 2010, some might say “there’s nowhere to go but “down.” Yet I know that the Board of Trustees and Staff feel quite the opposite, and I trust that the larger Barker community is equally energized and optimistic. The year 2011 holds exciting opportunities and promises of a dynamic year, albeit significantly different in contours from last year. Before we move forward, surely we can be forgiven for a nostalgic review of 2010.

Our dedicated and exceptional staff helped find permanent adoptive homes for 123 infants and older children, a record-high in 65 years of history. Our pre- and post-adoption education, training, and counseling touched more lives than ever before. And then there were the anniversary events! Our community came together over and

over to celebrate the 65th anniversary year. So many of you attended one or more remarkable events: the Salute to Freddie Mac Foundation/ Fundraiser for *Project Wait No Longer* at Ben’s Next Door; the Anniversary Conference with Collins Tuohy, Scott Simon, and 400 attendees and panelists; the family picnic which for many is a first introduction to the “Barker family”; the Colombia Homeland Tour reunion, with FANA parents and young adults sharing a special bond; the elegant reception at the Korean Ambassador’s residence, inspiring cultural pride in our Korean adoptees; the FCBA Young Lawyers’ Charity Auction, with *Project Wait No Longer* as the beneficiary; and the culminating event, the 65th anniversary gala.

In the current year, we are expanding many of our programs, including the older child adoption initiative and the China Waiting Child program. We are re-exploring our outreach and presence

in the Tidewater area. Our agency technology is being upgraded to render our staff even more efficient. Perhaps most challenging and significant, our Board of Trustees and Staff are beginning the process of strategic planning, in an effort to keep Barker both relevant and resilient. Trustees Abigail Wiebenson and Cherisse Robinson have agreed to Co-Chair the committee which will analyze where we stand now, where we want to go in the next three years, and what resources are required to get there. So 2011 will be anything but prosaic or business-as-usual. What is your vision for Barker? I invite each of you to be a part of the next chapter in Barker’s history.

The Inner Voice Speaks: A Parent's Perspective on the Colombia Homeland Tour

Nearly twenty years after my first time there, I returned with my son to his homeland of Colombia, along with other FANA parents and their teens. En route to the mountain peak of Monserrate on Day One, we stopped for a better look at the city below. Almost in unison, the teenagers raised their cameras to capture that first glimpse of Bogotá, as if to satisfy an unexpressed craving for possessing this place. My heart recalled a song that could well be an anthem to this deeply personal journey:

*"Listen, my child, you say to me,
I am the voice of your history.
Be not afraid, come follow me.
Answer my call and I'll set
you free."*

Discovering one's birth country is indeed a liberating experience. A Homeland Tour is a cultural enrichment trip, an open door to acceptance, a foundation for lasting friendships and a pivotal moment for your child. It truly is a gift that keeps on giving.

Apart from this profound potential, Barker's Colombia Homeland Tour is an extraordinary excursion and a feast for the senses. From the summit of Monserrate to the Zipaquira Salt Cathedral deep underground, you'll find a spectacular

Discussion of adoption stories will be handled with care in a setting permeated by evidence of beautiful children and joyous parents. Meeting expectant birth mothers at the Hogar will provide a forum for open and honest dialogue, revealing a deeply familiar bond among all participants and giving voice to a love never before articulated. As they've done for decades, Barker and FANA staff will offer their support. Their knowledge of Colombia and sensitivity to your unique needs will enhance your experience immeasurably.

Through the Homeland Tour, you'll embrace a country that has

Our celebration will be held on Thursday, May 19th, at the

American University Katzen Arts Center in Northwest Washington, DC. The event will feature a special performance by popular political satirists, *The Capitol Steps*, well known for creating fresh material that jibes politicians and political headlines. The group is Washington's own *Saturday Night Live*, *Second City*, and *The Daily Show* and they skewer both sides of the Congressional aisle. *The Wall Street Journal* says, "The troupe is a favorite in Washington. Its political satire brings chuckles... rave reviews...guffaws...and bipartisan grins all around. The satire hits the mark."

The Spring Benefit begins at 6:30 p.m. with a reception and silent auction in the Katzen Center's Rotunda. Benefit co-chairs **Mary Jaffe** and **Trish Warner** revealed that the silent

Amy's Story

Having adopted her older daughter from China, Amy Mauser was eager to complete her family through the adoption of a second daughter through China's regular program. Daunted by the increasing timeline for a referral, Amy made the decision to consider adopting a child with special needs and turned to The Barker Foundation's China Waiting Children Program. Here, Amy generously shares her own story of her decision to switch to the waiting children program and the truly joyful outcome of this decision. Her daughters, Dana and Emily, grace the cover of our website program guide, and their smiles speak volumes.

I started the process to adopt a second daughter from China when my first daughter, Dana, was in kindergarten. The summer before she entered third grade, as a family—Dana, my mother who lives with us, and I—began to reassess whether it made sense to continue to wait for a healthy referral from China, knowing the wait could be years longer.

I was not ready to give up my dream of a second daughter, and Dana wanted nothing more than to become a big sister. I therefore began to explore China's special needs program while keeping my dossier in the regular China program. One of the first requirements was to identify the special needs/health conditions that I would be willing to accept. I found this difficult to do in the abstract.

One Monday in October 2009 I received Barker's most recent agency-specific listing of special needs children. An 18 month old little girl immediately captured my heart. She was born with a cleft lip and palate; she had had surgery on her lip in China, but not yet on her palate. I immediately called Barker to say "I think I am interested." Barker sent me her file, and by that evening, in my heart, I had made the decision to proceed. I was so disappointed when the pediatrician we had used for years second-guessed my decision; this was not what I had expected. I spent the next week doing a lot of reading about cleft lips and palates and talking to specialists, family, friends, and a parent who recently adopted a baby with a cleft lip and palate. Nothing I learned caused me to

change my decision. I told Barker I was ready to proceed.

Once I decided to proceed, the process went amazingly and unexpectedly fast. Since my dossier was already on file with the China Center for Adoption Affairs, I was able to supplement it relatively quickly. About a month after the CCAA received my application, on Thanksgiving Day, I received Preliminary Approval (PA). It was a very special Thanksgiving since I was able to share with Dana the news that she was soon going to become a big sister. I did not realize how soon. In the past it has typically taken 3 to 4 months from PA to final approval. Very unexpectedly, the following week I received a call from Barker with the news that the CCAA had granted final approval. We were in shock. Although I had been waiting for years for a second daughter, I had done nothing to prepare. All of a sudden there was so much to do.

My Mom, Dana, and I traveled to China in late January, and Emily joined our family on February 1, 2010. I had prepared myself for a rough transition since Emily was older than Dana when I adopted her, and she had lived with the same foster family since she was two weeks old. The transition, however, could not have gone more smoothly. On the morning of Gotcha Day, someone from the orphanage picked Emily up from her foster family and brought her to the Civil Affairs Bureau to meet us. After meeting us, Emily cried herself to sleep, but by lunchtime she was ready to eat and play with Dana. When we got home

from China, she was so excited to finally be home; before we collapsed from the long trip, she explored each room in the house with a smile on her face as if to say "I am finally home and so happy to be here."

We scheduled Emily's surgery to repair her palate a couple of months after we came home (in April). Emily was in the hospital for only a little over a day. Even though she was on an all liquid diet when we came home and had to wear arm



splints to prevent her from placing her hands in her mouth, that did not stop her from having fun playing and enjoying meals. I became a pro at making new liquid meals; I sometimes think Emily enjoyed those meals even more than she enjoys my regular cooking! The

most exciting signs that the surgery was a success were her ability to kiss and to say "bye bye" instead of "my my" for the first time, but for a period thereafter, she did not seem to say much more. By summer, however, she was starting to say more and more, and she also began speech therapy. Her therapy initially focused on getting her to use language, and once her vocabulary increased, her therapy also began to focus on pronunciation. Emily enjoys therapy, particularly when she gets to do exercises with fluff-ernut, chocolate, or peanut butter to help her learn to put her tongue up to her palate to make certain sounds. She regularly brings me the ingredients for these exercises while we are in the kitchen so she can practice.

While I adopted Emily through the "special needs" program, I have never considered her to be a "special needs" child. Most of the time, as a family, we do not focus on Emily having been born with a cleft lip and palate. Instead, we focus on all the new things that she is doing each day, and how proud she is of herself when she does something for the first time and says with a big smile "I did it." On the recent first anniversary of Emily's Gotcha Day, my Mom, Dana and I celebrated how blessed we are that Emily is a part of our family and the joy that she has brought all of us. ■

"Hundreds of children like Emily are in the China Waiting Children program waiting for a loving family who could help them to reach their potential. The children in the program include boys and girls who have minor to severe medical conditions, or who are simply older. Unlike most of the other international programs, this is a fast-moving program. Families may select the age, sex and medical condition of the child they wish to adopt. The majority of our families are matched with a child within one to three months after their paperwork is ready, and families normally can bring their child home within seven months after they are matched.
