

International Adoption Program Fees for Service

The Barker Foundation is non-profit and derives less than 50% of its revenue from fees for services; the remainder comes from contributions, fund raising and other grants. Adoption services are costly because of the time intensive nature of the counseling process and because of the extensive requirements of both the courts and state licensing. Fees are for services rendered and cannot guarantee the placement of a child. Fees are adjusted periodically by the Board of Trustees.
